**VISA REQUIREMENTS FOR JAMAICANS TRAVELLING OVERSEAS AND
FOREIGNERS ENTERING TO JAMAICA**

***British Virgin Islands** – The following categories of persons are visa exempt without payment of a visa exemption fee:

- a. Overseas diplomats and dignitaries;
- b. Heads of State and Heads of Government;
- c. Consultants engaged by the Government and Statutory bodies of the Territory;
- d. Persons employed on contract by the Government;
- e. delegates for Government-sponsored conferences or other events;
- f. Regional or International group invited by Government agencies for tourism cultural or educational purposes and;
- g. Dependent children of not more than 18 years old and enrolled in schools in their home country, whose parents reside in the Territory and are nationals of Guyana, **Jamaica**, Haiti or the Dominican Republic.
