EMERGENCY CERTIFICATE APPLICATION

An Emergency Certificate (EC) is a one-way travel document designed for **emergency travel** to Jamaica only and is not generally recognized by other territories, as it is neither bar-coded nor does it have an expiry date. The applicant will be required to do a passport renewal/replacement once they are in Jamaica.

The requirements for an Emergency Certificate (EC) are as follows:

- Last issued Passport
- Completed Passport application form (notarized if submitting via post)
- Two photos (one to be notarized if submitting via post)
- Flight Itinerary which clearly states the Airline, Flight date and time and flight number
- Original Birth Certificate
- Original Marriage Certificate, Divorce Decree and Deed Poll (if applicable)
- Valid Government-issued Photo ID (notarized copy of the front and back if submitting via post)
- Detailed Statement surrounding the loss of passport, if the document is unavailable for submission with the application
- For minors, a notarized copy of the parent's valid ID is required and the original of any other name change document that is required (i.e.; Marriage Certificate).
- All applicants are required to submit Proof of Emergency (document/s that correspond/s with the emergency for which the application is being made).
- For in-person submission, applicants are required to transmit an email to the Embassy of Jamaica, Washington D.C., for appointments, which must be approved prior to visiting.
- Application Fee - \$95 (including mailing fee); \$75 (without mailing fee)
- In the case of mailed-in EC applications, in addition to the self-addressed prepaid envelope, applicants are also required to notify the Embassy of Jamaica, Washington D.C, by way of email.

PROCESSING TIME

The processing time for ALL Emergency Certificate (EC) applications may take approximately 10 business days. **The Embassy of Jamaica, Washington D.C., reserves the right to request any additional/updated document/s that may imply additional time.**

The acceptable method of payment is cash or debit card (*a surcharge is applied by the banking machine used for debit card*) for in-person applicants, or Money Order made payable to the “Embassy of Jamaica” for mailed-in applicants.

The Embassy of Jamaica, Washington DC, encourages all fellow Jamaicans to ensure that their travel documents are up-to-date ahead of their travel arrangements. In the case of EC applications, in the event of non-compliance, the Embassy of Jamaica, Washington D.C., will not be held responsible for any inconveniences caused.
